<b>Subject Matter</b>	<p><b><u>Argus Automatic Activation Device (AAD), testing and approval for use in the Dual Hawk Tandem System</u></b></p> <p><b>STRONG ENTERPRISES, Product Service Bulletin # 29, dated September 5, 2008.</b></p> <p><b>Strong Enterprises Service Bulletin # 29 authorises the use of Argus AAD, date of manufacture 05/2007 or later, and Dual Cutters, date of manufacture 01/2007 or later, when installed in accordance with the Dual Hawk Tandem Manual installation guidelines, P/N 510045, Rev.
